Department Reports

<u>Veteran's Department Update</u> Linda Skendzel, Veterans Service Officer

- A written update and Quarterly Report for October-December 2015 were provided in advance of the meeting for the Commissioners to review. Because there were no questions from either report, Ms. Skendzel relayed a success story she had in helping a veteran obtain long awaited dental work. She explained the difficulty veterans encounter when attempting to claim dental work as a result of an injury during service, which was the case in this situation. This particular veteran's dental work was estimated at \$6,000 by one dentist, but Advantage Dental was willing to do the work for substantially less.
- Ms. Skendzel asked if the Court would be in favor of an expenditure of \$150 from her budget to purchase an American flag that will be raised during specific national holidays at Desert Lawn Memorial Cemetery in Irrigon. The American Legion, Post 37, Hermiston, which also serves Morrow County, is selling the flags, and she said she would be willing to contribute toward similar memorials at other County cemeteries, if or when, she becomes aware of those opportunities.
- Ms. Skendzel provided a brief summary of several proposed legislative bills and discussed upcoming conferences for veterans.

Herbicide Bid Award

Mr. O'Brien said staff reviewed the three bids and recommended awarding to the low bidder, Crop Production Services, Inc.

Department Report

Planning Commission Appointment

Carla McLane, Planning Director

Ms. Wolff confirmed she received verbal notification from Ken Bailey, Heppner, of his interest in serving on the Planning Commission. Ms. McLane noted two attempts at advertising the opening on the Commission were unsuccessful.

Commissioner Rea moved to appoint Ken Bailey to the Morrow County Planning Commission with the term effective this date, through December 31, 2019. Commissioner Russell seconded. Unanimous approval.

Planning Department Update

- Federal Emergency Management Agency's review of Morrow County's Natural Hazard Mitigation Plan Ms. McLane said there are a few problem areas that need to be addressed prior to adoption.
- Joint Management Agreements with each community in the County regarding management of Urban Growth Areas the most recent update was in 2002 and new versions are near completion.
- Love's Travel Stops and Country Stores/Devin Oil Appeal Process Ms. McLane said the deadline for appeals was February 2nd, so it appears this matter is now behind us.

New Business

Affidavit for the Partial Cancellation of a Water Right Certificate

Ms. McLane explained that this is a request from the Water Resources Department through West Extension Irrigation District regarding water rights under Root Lane and Meadow Loop Road. She said the rights were not addressed at the time the subdivision was built; are not needed by the County; and West Extension would like them back.

Commissioner Rea moved to approve the Affidavits for Partial Cancellation of a Water Right Certificate, Number 86491 (Grieb Farms, Inc.) and Number 86492 (Craig Pritchard), and authorize Judge Tallman to sign on behalf of the County. Commissioner Russell seconded. Unanimous approval.

<u>Utility Easement – City of Heppner</u> Jerry Sorte, Administrative Officer Kim Cutsforth, Manager, City of Heppner

Mr. Sorte presented the updated easement which has been amended to address his previous concerns. The easement request pertains to the property where the new fire hall will be constructed. Mr. Sorte discussed the concerns and solutions in detail.

<u>Columbia Gorge Bi-State Regional Energy Zone (CGBREZ) – Mid-Columbia Wind Projects</u> Judge Steve Shaffer, Gilliam County Dana Peck, CGBREZ David Van't Hof, Consultant for CGBREZ

The group came to ask Morrow County to participate in the cost to hire the consultant to create Purchase Power Agreement opportunities, such as in California, for Mid-Columbia wind projects. Judge Shaffer said the request is for \$10,000. Various discussions ensued.
