Feasibility Study for a Morrow County 4-H, Oregon State Extension & Agriculture Research Service District July 16, 2017

Introduction

The federal Smith-Lever Act of 1911 established a system of cooperative extension services to be delivered through land grant universities by university agents in individual counties of states with land grant institutions. The county extension agent and county extension services were the result of this legislation. The Act mandated that such services be funded by a combination of federal, state, and county monies.

For almost 100 years in Extension and 108 in Research, Oregon State University has had a partnership with Morrow County to extend the knowledge of the land grant university to the citizens of this county. The Morrow County Extension Service was created in 1918 to support local agricultural interests. In 1909, the Agricultural Experiment Stations - Columbia Basin Agricultural Research Center, (CBARC) and Hermiston Agricultural Research and Extension Center (HAREC) were established in neighboring Umatilla County, though not located in the Morrow County, they extensively serves Morrow County's dryland and irrigated farmers.

The Mission of EXTENSION, HAREC AND CBARC is to deliver objective, researchbased scientific information to support Morrow County's farmers, ranchers, youth, gardeners, small farm owners, and woodland owners. Today, the Experiment Station side of HAREC and CBARC helps agriculturalists develop the best sustainable practices in their fields, and contributes to their remaining competitive in a global economy. Together, the Extension Service and the Experiment Station form the OSU team in the county (EXTENSION, HAREC AND CBARC), although they continue to maintain separate missions and budgets.

Since the inception in 1918 and 1909, Morrow County has provided significant financial support and other assistance to those programs. Even though Morrow County has provided only about 6% of EXTENSION, HAREC AND CBARC's budget (\$2.98 million) in recent years, this funding is vital as a match for the federal and state dollars invested in Morrow County through EXTENSION, HAREC and CBARC. Without it, the matching funds cannot be invested and Extension and serving Morrow County cannot exist.

Because of the many vital services provided to the citizens and businesses of Morrow County by both the Extension Service and Experiment Stations, it is critical that a sustainable, secure and steady funding source be found. This feasibility study details EXTENSION, HAREC AND CBARC's contributions to Morrow County, its relationship to other county service providers, and the feasibility of creating sustainable funding through the formation of a service district.

EXTENSION, HAREC AND CBARC's Role in Morrow County

EXTENSION is located in two different locations across Morrow County, while HAREC AND CBARC are both serving the needs of Morrow County producers and its \$500 million farmgate valued agriculture. It supports programs of practical and relevant interest to citizens in rural environments across Morrow County and the Columbia Basin of Oregon. Programs and

program staff are valued and trusted by the community because of their responsiveness to the issues that most strongly resonate within the community.

Both of EXTENSION, HAREC AND CBARC's units serve as front doors to Oregon State University, Oregon's land grant university, and its resources. EXTENSION, HAREC AND CBARC are out there making the research and knowledge base of OSU available in communities throughout the County, a role it has played since 1918.

Extension's resources and programs center on building and strengthening sustainable communities and economies, sustaining natural resources and agriculture, and enhancing the health of youth, families, and older adults. Information is disseminated by EXTENSION, HAREC AND CBARC staff via workshops, classes, tours, demonstrations, online, technology, and face to face. This high-quality, research-based information meets the community's demand for reliable, easy-to-access education for an increasingly diverse, growing and changing population, providing lifelong educational opportunities.

EXTENSION, HAREC AND CBARC's professional staff works cooperatively with numerous community partners. In addition, staff members develop and train a network of volunteers that expands the reach of services into all corners of the County. Volunteers are trained as 4-H Leaders, and Insect-Train-the Trainers. In 2016, this combination of professional staff and trained volunteers enabled EXTENSION, HAREC AND CBARC to make more than 99,000 contacts with county residents in Morrow and Umatilla Counties.

EXTENSION, HAREC AND CBARC's Extension activities in and serving Morrow County are currently organized into the following program areas, each of which provides a combination of educational programs and skill development activities and information services, supplemented by a vast library of user-friendly publications and web-based resources: 4-H Youth Development

- □ Club projects in civics and leadership, science and technology, animal husbandry, natural science, horticulture, expressive arts, and science and technology
- □ Latino families outreach in college and career readiness
- □ After-school and summer youth natural resource programs
- □ County Fair
- □ Leadership development workshops

- □ 4-H Leader volunteer program
- □ Tri-County 4-H Camp

Collaboration with Other County Agencies

While other organizations and agencies provide educational services in Morrow County, Extension is unique in its scope and capacity. Consider the following examples: The public schools in Morrow County educate youth; Extension's 4-H Youth Development Program provides an array of after-school, in-school and club-based learning opportunities that build leadership skills, foster responsibility, engage youth in citizenship, and enhance their appreciation of natural resources and our environment. According to the *Report of the Findings from the First Eight Years of the 4-H Study of Positive Youth Development* (Tufts University and the National 4-H Council, 2012), youth in 4-H programs are:

- □ 3.5 times more likely to contribute to their communities;
- □ 1.5 times more likely to have positive youth development;
- □ 1.6 times more likely to go to college;
- □ Less likely to develop depressive symptoms and delinquent behavior.

Blue Mountain Community College provides higher education and workforce training opportunities in automotive, diesel mechanics, medical and agricultural fields; EXTENSION, HAREC AND CBARC works alongside by bringing cutting-edge research knowledge to farmers, ranchers, foresters, and other natural resource managers, and helps them integrate this information into their production and marketing efforts.

EXTENSION, HAREC AND CBARC:

- □ Educates new landowners on farming practices, horticultural commodities and cropping systems specific to this area;
- □ Emphasizes sustainable and organic production;

- □ Provides innovative problem-solving techniques and alternative pest control;
- Disseminates information and resources on emerging production practices and technology;
- □ Supports local food production;
- □ Promotes water quality and watershed health and management;
- □ Preserves and conserves open space by protecting agriculture's viability in the region and evaluating alternative land use.

The County's Health and Human Services Division and our local health care industry provide services to treat health conditions; EXTENSION, HAREC AND CBARC's nutritional and Family Community Health program helps Morrow County residents avoid food-related illnesses, take advantage of our abundant, locally-grown produce, and help our senior citizens to maintain a healthier life.

EXTENSION, HAREC AND CBARC:

- Provides unduplicated health promotion and prevention programs for adults and youth;
- □ Helps food pantry clients stretch their limited food dollars and enjoy a healthier diet
- □ Works with food service providers to make system level improvements to healthier food choices in schools.

Various state, federal and county agencies provide technical and financial assistance to landowners and enforce land use regulations; EXTENSION, HAREC AND CBARC works proactively to teach landowners best management practices that maintain productivity and financial viability on a sustainable basis—a major contribution to Morrow County's economy. EXTENSION, HAREC AND CBARC connects our community to OSU and its resources by providing:

- □ Staff members who know the needs of this community because they live and work here, and are passionate about what they do;
- □ Timely responses to questions and applied knowledge and skills as it has for more than 100 years;
- □ Explanation and implementation of new and complex technologies that respond to the needs, conditions and opportunities of this region;
- □ The belief that when the community is successful, EXTENSION, HAREC AND CBARC are successful.

The faculty and staff of EXTENSION, HAREC AND CBARC's the Extension and Research mission by conducting applied research in the areas of potato variety development, annual cereal grains, alternative crops, woodland products, and integrated pest management, and disseminating that information to local agricultural producers and interested parties within the region. EXTENSION, HAREC AND CBARC staff members also support the County's small farms, whether long established or newly launched. This service is highly relevant in a community that highly values safe, sustainable, healthy, local food production and the protection of our farmlands.

EXTENSION, HAREC AND CBARC serves county residents across all age groups, social classes, occupations and avocations. In 2016, the EXTENSION, HAREC AND CBARC delivered hundreds of high quality educational programs, workshops, and projects that reached more than 99,000 residents in Morrow and Umatilla Counties. More than 225 youth from 4th

through 12th grades participated in EXTENSION 4-H youth development programs. EXTENSION, HAREC AND CBARC are also an important information brokers to the entire community. If EXTENSION, HAREC AND CBARC's faculty, staff or volunteers can't answer a question, they know someone who can and refer it to them.

Partnership Opportunities

EXTENSION, HAREC AND CBARC staff members work hard to use limited funding resources effectively. They look for opportunities to extend program reach through partnerships with other organizations and by reducing duplication of programs and projects.

Morrow County Funding Situation

EXTENSION, HAREC AND CBARC depends on county, federal and state funds to provide the funding base for its operations. In recent years, Morrow County funds have provided about 6% of the \$ 2.98 million budget for Extension and Research.

Federal and state governments support specific projects with grants, and pay a portion of the statewide programs and faculty salaries. Since the early 1900's, Oregon State University has maintained this partnership among the government agencies here in Morrow County, but as revenues have shrunk at all levels of government, OSU and Morrow County are unable to provide previous levels of funding and staffing.

EXTENSION, HAREC AND CBARC Funding Options

Grant writing, fees for services, commodity commission contributions, and generation of local program support are a regular component of EXTENSION, HAREC AND CBARC faculty members' jobs, yielding about \$1.675 million annually for EXTENSION, HAREC AND CBARC programs and accounting for about 56% additional resources to address research and educational programming.

Although it might, appear that shifting more efforts toward writing and obtaining grants would be an option, in all likelihood, such a shift would result in a dramatic change in emphasis in order to meet narrowly defined grant requirements. This change in focus would markedly decrease programs and service to the residents of Morrow County.

It has also been recommended that EXTENSION, HAREC AND CBARC increase revenue by collecting more money from its various program associations, soliciting donations from the community, conducting raffles, and/or charging more for services and classes. However, these sources of revenue are not sufficient to maintain strong programming and place an additional burden on those who may need our services the most such youth and limited income community members.

The EXTENSION, HAREC AND CBARC FRIENDS OF EXTENSION committee a diverse group of stakeholders from this county, has reviewed many options to provide a secure and sustainable funding source for EXTENSION, HAREC AND CBARC. This group has determined that it is necessary to ask the citizens of Morrow County to support the formation of a county service district. This district would have an associated tax base specifically dedicated to the support of all of the Extension Service programs in Morrow County. The district would provide operations support for the EXTENSION, HAREC AND CBARC office including office, lab and equipment space; secretarial support; program assistance; program supplies; utilities and equipment; and the maintenance of equipment and buildings.

EXTENSION, HAREC AND CBARC Capacity for Expanded Community Service

EXTENSION, HAREC and CBARC's FRIENDS OF EXTENSION have reviewed EXTENSION, HAREC AND CBARC programs and activities, and have identified a number of issues to which EXTENSION, HAREC AND CBARC is well positioned to respond.

- Increasing focus on youth workforce preparedness and life-skill development through school enrichment, camps, and special interest/short-term activities.
- Help homeowners, farmers, ranchers, and foresters to learn new techniques to solve production issues and to become more profitable in order to maintain our local economy
- Continue to bring an additional \$5 in state, federal and other grant funds for every \$1 invested by the service district
- Teaching sustainable gardening skills through the Extension Master Gardener program
- Targeting small-scale famers and producers to teach them how to add value to land and farm products through activities such as direct marketing and product development.

Faculty positions, funded by state and federal dollars, provide programming in these areas, but are dependent upon County-based, grants or community-based resources for program support and staffing.

Proposal

The EXTENSION, HAREC AND CBARC's FRIENDS OF EXTENSION group recommends that EXTENSION, HAREC AND CBARC maintain its offices at the current locations, and that programs continue in 4-H youth development, natural resources, family community development (food safety, nutrition and programs for aging), agriculture, and applied research. EXTENSION, HAREC AND CBARC FRIENDS OF EXTENSION recommends that a service district be formed to provide local support for EXTENSION, HAREC AND CBARC's operations, including funding (initially):

Morrow Count Extension 4-H Agent (faculty) .40 FTE Office support staff 1 FTE Columbia Basin Ag Research Center Bio Tech II .45 FTE Bio Tech I .30 FTE General Mechanic .30 FTE Office support .30 FTE Hermiston Ag Research and Extension Center Bio Tech II 1 FTE Bio Tech I 1 FTE Office support 1 FTE

Assistant Professor of horticulture .25 FTE

The funding requests for HAREC and CBARC would be funded from both proposed districts: 40% from Morrow County's funding and 60% from Umatilla County's funding.

EXTENSION, HAREC AND CBARC FRIENDS OF EXTENSION further recommends that the service district provide funding for management and maintenance of the buildings, farm equipment and grounds at EXTENSION, HAREC AND CBARC in Heppner, Hermiston, and Pendleton, Oregon.

District Governance

Funds collected by the service district would be used solely in support of EXTENSION, HAREC AND CBARC programs that qualify for service district funding, including a wide array of Extension educational programs responding to local needs, and the research activities that inform those programs. EXTENSION, HAREC AND CBARC would continue to provide services through a memorandum of understanding with Oregon State University and the district. The County Board of Commissioners would be the service district's governing body, as required by statute.

Summary

OSU, through its Extension Service and Branch Experiment Station, provides valued non-formal education, applied research, and a wealth of practical information to Morrow County residents. These services have been supported in part by direct financial support from the county general fund for the past 100 years. To assure that the Extension, HAREC and CBARC and its many programs will have stable funding and will be able to continue to provide educational resources, applied research and support for sustainable agriculture to the citizens, agricultural enterprises and businesses of Morrow County, the Board recommends that a measure to form this service district and to provide a permanent tax base be placed on the May 2018 ballot in Morrow County.

The service district would be funded by a permanent tax rate limit of up to \$0.33 per \$1,000 of assessed value to provide operating support for the OSU educational and research activities and programs that qualify for service district funding in order to ensure that the Experiment Stations and the Extension Service can continue to serve the citizens of Morrow County. The District would implement a maximum rate of \$0.33 per \$1,000 assessed value to fund Extension programs. A home assessed at \$125,000 would pay approximately \$41 per year.

AGREEMENT

This agreement made as of the <u>day of</u> <u>2017</u> by and between Morrow County, a political subdivision of the State of Oregon Morrow and Turner Ranch Inc. A Company (Lessor, Land Owner):

WITNESSETH:

That whereas Lessor is the owner of certain real property located in Morrow County, Oregon, to-wit; the NW ¼ of Section 17 Township 2 South, Range 27 E.W.M.; and

Whereas, County desires to use the quarry site located upon said property for the purpose of extracting solid rock to be used for making gravel, said gravel being necessary for the construction, maintenance and repair of County roads; and

Whereas, it will also be necessary for County to obtain the use of additional property for the purpose of storing stockpiled gravel near the quarry site;

NOW THEREFORE, the parties are agreed upon the following terms and conditions:

1. Lessor hereby grants to County the right to use the quarry site located upon the abovedescribed property for the purpose of blasting and extracting rock, and setting up crusher to make gravel there from, and also grants to County the right to use property adjacent thereto for the purpose of stockpiling and storing said gravel; the property used for stockpiling purposes shall be no greater than five acres.

2. The following definition shall apply:

"Solid yard" of rock means one cubic yard of rock in the unquarried, and unblasted state.

3. The term of this agreement shall be for a period of five (5) year(s) commencing May, 2017, and terminating on May, 2022 with optional one-year renewals hereof for stockpile purposes only, up to a maximum of ten (10) years from the date hereof.

4. County shall crush the rock extracted at the site and shall pay to Lessor the sum of \$0.25 (twenty-five cents) per solid yard of rock extracted. Lessors shall notify County, in writing, at the commencement of each crushing season whether payment for that year's production shall be made in cash, in kind, or in a specific combination thereof. In kind values of processed rock to be determined each year.

5. In addition to the fees and charges set forth, County shall pay to Lessor the sum of Two Hundred Dollars (\$200.00) per year for use of the property upon which gravel is stockpiled; the first such payment shall be made within twenty-one (21) days of drilling and blasting, with a like payment being made on or before the first day of January for each and every year thereafter during which gravel is stored upon the property.

6. All payments to be made by County to lessor under the terms of this agreement shall be made in the form of checks, and said checks shall be made payable to "Turner Ranch Inc.".

7. Lessors shall load and haul the rock set aside as the "in kind" payment at a time and in a manner, which does not unreasonably interfere with County operations at said quarry pit site. Lessors will accept delivery of said crushed rock at the quarry location and will load and haul it at their own expense and convenience.

8. Lessor hereby reserves the right to utilize the above-described property for grazing purposes. Lessor covenants and agrees to exercise their right in a manner, which does not unreasonably interfere with County's use of the property as provided above. County agrees to effect timely repair of any damage caused by County operations to any fencing surrounding the property or to the gates or gateposts, which are a part hereof. Repairs made within fifteen (15) days of written notification of any condition-requiring repair shall be considered "timely".

9. Lessor shall make no claim of any kind or nature against County which might arise by reason of damage done to real or personal property as the result of the rock extraction and crushing, stockpiling or transportation operations necessarily contemplated by this agreement, except as may be specifically provided herein; Lessor agrees to this paragraph being fully aware of the potential effects of said activities upon such property as, but not limited to, his livestock, water springs or flow, and hereby releases and holds County harmless from any and all such liability. Also, if for some unforeseen reason any payment should be reasonably late, it will in no way effect the continuation of this agreement as it is written.

10. County shall, at its own expense, clean the gravel quarry site and shall remove and dispose of all trash and scrap metal; the site shall not be allowed to become cluttered or unsightly. County shall, at it's own expense, take such measures as are necessary to control and prevent the growth of spread of noxious weed on the property as such weeds are defined by County ordinance. Upon the expiration or termination of this agreement, or at such other time as all stockpiled gravel is removed from the storage site as provided herein, County shall clean said storage site and restore it in accordance with the standards required by the Oregon Department of Geology.

11. In the event that County is unable to perform its obligations hereunder by reason of inability to obtain funds through the budgetary process, then this agreement shall be terminated, and shall be of no further force or effect, and shall not be binding upon either party.

12. In the event suit or action is brought to enforce the terms and provisions of this agreement, or



MID-COLUMBIA NATIONAL WILDLIFE REFUGE COMPLEX

THIS MEMORANDUM OF UNDERSTANDING is entered into by Morrow County Sheriff, and the U.S. Department of the Interior, U.S. Fish & Wildlife Service (Service). Mid-Columbia National Wildlife Refuge Complex (MIDCOL) (hereinafter collectively referred to as the Parties) to provide for cooperation in the use of personnel and equipment for the common purpose of protecting the lives, property, and resources of the public they serve.

I. PURPOSE AND AUTHORITY:

Whereas - <u>National Wildlife Refuge System (16 U.S.C. 668 dd)</u>: The Secretary of the Interior, through the U.S. Fish & Wildlife Service, administers various lands and waters within the State of [state] which are part of the Service's National Wildlife Refuge System.

Whereas - <u>Cooperation with the State and Local Governments Regarding Migratory Birds</u> (16.11.S.C 715 *et seq.*): The Migratory Bird Conservation Act authorizes the Secretary of Interior to cooperate with the State and local governments in law enforcement activities.

Whereas - <u>Cooperation with States for Law Enforcement (16 U.S.C 7421)</u>: The Fish and Wildlife Improvement Act of 1978 authorizes the Secretary of the Interior to enter law enforcement cooperative agreements with State or other Federal agencies.

Whereas - the United States Congress has given the Secretary of the Interior the authority to enforce certain laws dealing with public protection and conservation of fish, wildlife, and other natural resources and this authority has been delegated to the Director of the Service and to certain qualified individuals.

Whereas - the Secretary of the Interior has also determined that in cases where a specific need for

law enforcement assistance and investigative support has been identified or where a law-enforcement emergency or a violation in progress exists, it would be mutually beneficial, economical, and advantageous, and in the public interest to cooperate with State and local law enforcement agencies.

Whereas - the Service is responsible for public safety on Service managed lands and facilities and recognizes the continued need to support working relationships and assist neighboring law-enforcement agencies through agreements.

Whereas - the Service Officer's covered under this agreement have been granted Federal Officer Arrest Power pursuant to O.R.S. 133.245(6), by the state of Oregon.

Whereas - the U.S. Department of the Interior, U.S. Fish & Wildlife Service (Service). Mid-Columbia National Wildlife Refuge Complex (MIDCOL) request use of radio frequencies controlled and operated by the Morrow County Sheriff Office to help coordinate law enforcements activities in Morrow County.

Now therefore - the Parties have determined that providing of specified law enforcement aid and assistance across jurisdictional lines will increase their mutual ability to preserve the safety and welfare of law enforcement personnel and the public, and that use of the Morrow County Sheriff Office law enforcement radio frequencies will further that assistance and benefit to the community.

II. AUTHORITIES

This Memorandum of Understanding, (MOU) represents an agreement for mutual law enforcement support between MIDCOL and Sheriff. Under the terms of this agreement, Federal Wildlife Officers of MIDCOL will be allowed use of Morrow County radio frequencies as approved by the Morrow County Sheriff Office.

A. Law Enforcement Assistance off Service lands.

1. The situations which the Service is authorized to provide law enforcement assistance within the jurisdiction of the Morrow County Sheriff under this agreement consists of all of the provisions of the Federal Arrest Authority provided by the state of Oregon, and specifically:

a. All that needs to be shown is that a state or county law enforcement officer needs assistance or requests the assistance of a federal officer.

b. With the exemption of emergency law enforcement response, assistance by Federal Wildlife Officers will be limited to a 20 mile radius of a National Wildlife Refuge, unless supervisory approval has been completed.

c. K-9 units are specifically authorized to assist the same as any Federal Wildlife Officer according to Federal Arrest Authority provisions and Fish and Wildlife Service agency policy.

B. Morrow County Sheriff Assistance on Service Lands.

1. It is understood that the Morrow County Sheriff has full concurrent jurisdiction on lands owned by the U.S. Fish and Wildlife Service in the county and is able to assist at any time.

III. RADIO FREQUENCY AGREEMENT

Morrow County Sheriff agrees for Federal Wildlife Officers to transmit and receive on the frequencies listed below, which are operated and controlled by the Morrow County Sheriff Office. The ability to use the Morrow County law enforcement frequencies can be terminated at any time by the Morrow County Sheriff or his designee. Providing the use of the radio frequencies for the parties of this agreement is considered a mutual benefit for all parties.

Approved Frequencies:

See Attachment A

IV. PROPERTY MANAGEMENT AND DISPOSITION

No direct funding is required by this agreement and no property, real or personal shall be acquired, managed or disposed of hereto. The law enforcement agency or each party will maintain its own personnel and equipment, and each will be responsible for all cost for emergency or routine assistance if it occurs as a result of an incident.

V. REQUIRED CLAUSES

Each party will be responsible for damages or loss resulting from the actions of its own personnel, when rendering emergency or routine assistance. Each party will be responsible for all legal actions arising from the improper or alleged improper conduct of its own personnel.

Each party will be responsible for ensuring their officers are current with required training according to agency policy and use of radio equipment.

During the performance of this agreement, the participants agree to abide by the terms of Executive Order 11246 on non-discrimination and will not discriminate against any person because of race, color, religion, sex or national origin. The participants will take affirmative action to ensure that applicants are employed without regard to their race, color, religion, sex or national origin.

No member or delegate to Congress, or resident Commissioner, shall be admitted to any share or part of this agreement, or to any benefit that may arise there from, but this provision shall not be construed to extend to this agreement if made with a corporation for its general benefit.

Notwithstanding any provision herein, nothing shall commit the Service to incurring monetary

obligations for the purposes of this agreement, except to the extent funds are provided in Congressional Appropriation Acts. The provisions contained hereof constitute the entire agreement between the parties hereto.

In witness whereof, the parties have caused the reciprocal police aid and assistance agreement, to be executed the day and year first above written.

VI. TERMS OF AGREEMENT

1. This agreement becomes effective on the date signed by both parties and shall continue in effect until terminated.

2. The Agreement may only be revised or amended by consent of both parties. Such revisions or amendments shall not be effective until reduced to writing and signed by both parties.

3. This Agreement may be terminated by either party with written, electronic, or verbal notice to all parties.

VI. MEMORANDUM OF UNDERSTANDING

EXECUTED by the Parties hereto, each respective entity acting by and through its duly authorized official as required by law, on multiple counterparts each of which shall be deemed to be an original, on the date specified on the multiple counterpart executed by such entity.

Because the funds were decreasing the County Court decided to stop funds to the Sheriff's Office and transfer the funds to the Road Department.

- 5. <u>STAFF RECOMMENDATIONS</u>: The Sheriff Office continues to receive a small amount of money from the Forest Service each year. In addition, we respond and investigate Search and Rescue calls on concurrent Forest Service lands which come from the Sheriff's Office county funds. It would seem reasonable that because the Sheriff's Office is performing law enforcement services and SAR services that a portion of our work should be paid by PILT funds on federal lands which are deemed to be concurrent jurisdiction between Morrow County Sheriff's Office and federal law enforcement local Forest Ranger management shared responsibilities. There appears to be a significant a increase in PILT funds and I would like to hear how the BOC Commissions feel about returning some funding of the PILT funds to the Sheriff's Office.


