## ☰ Hazard Mitigation Assistance

Hazard mitigation is any action taken to reduce or eliminate long-term risk to people and property as a result of natural disasters. Hazard mitigation planning is a process used by State, tribal, and local governments to identify risks and vulnerabilities associated with natural disasters, and to develop mitigation strategies to reduce or eliminate long term risks. Hazard Mitigation Assistance (HMA) grant programs funded by Federal Emergency Management Agency (FEMA) may include, but are not limited to buy-outs, elevations and safe rooms.

The Mitigation and Recovery Services (MARS) Department of the Oregon Office of Emergency Management (OEM) employs one full-time State Hazard Mitigation Officer (SHMO), a planner, and several accounting personnel to administer the HMA grant programs at the State level.

There are three programs under HMA: The Hazard Mitigation Grant Program (HMGP), the Flood Mitigation Assistance (FMA) Program, and the Pre-Disaster Mitigation (PDM) Program.

- HMGP (<https://www.fema.gov/hazard-mitigation-grant-program>) assists in implementing long-term hazard mitigation planning and projects following a Presidential major disaster declaration.
- PDM (<https://www.fema.gov/pre-disaster-mitigation-grant-program>) provides funds for hazard mitigation planning and projects on an annual basis.
- FMA (<https://www.fema.gov/flood-mitigation-assistance-program>) provides funds for planning and projects to reduce or eliminate risk of flood damage to buildings that are insured under the National Flood Insurance Program (NFIP) on an annual basis.

HMGP funding is generally 15 percent of the total amount of federal assistance provided to a State, Territory, or federally-recognized tribe following a major disaster declaration. PDM and FMA funding depends on the amount Congress appropriates each year for those programs. Because OEM strives for excellence and maintains Enhanced Plan status, Oregon is eligible to receive up to 20 percent of assistance for the estimated aggregate amounts of disaster assistance. PDM and FMA funding is appropriated by FEMA annually for a given fiscal year (some years, there may not be funding appropriated).

Individual homeowners and business owners may not apply directly to FEMA. Eligible local governments may apply on their behalf. All eligible applicants, including special districts, must have a FEMA-approved Natural Hazard Mitigation Plan (NHMP) in place prior to applying for funding. ## ☰ Emergency Management Performance Grant (EMPG) Program

The Emergency Management Performance Grant (EMPG) Program makes grants to states to assist state, local, tribal and territorial governments in preparing for all hazards, as authorized by the Robert T. Stafford Disaster Relief and Emergency Assistance Act (<https://www.fema.gov/robert-t-stafford-disaster-relief-and-emergency-assistance-act-public-law-93-288-amended>) (42 U.S.C. 5121 et seq.).

Oregon Emergency Management (OEM) applies to FEMA for EMPG Program funds on behalf of the State of Oregon and its local and tribal emergency management agencies, as the eligible entity.

Title VI of the Stafford Act authorizes FEMA to make grants for the purpose of providing a system of emergency preparedness for the protection of life and property from hazards in the United States. The Act puts responsibility for emergency preparedness jointly in the federal government, and the states and their political subdivisions. Through the EMPG Program, the federal government provides direction, coordination, guidance and necessary assistance to Oregon, as authorized by the Act, so that a comprehensive emergency preparedness system exists for all hazards.

## ☰ Fuel Storage Facility Compatibility Fund Grant

The Fuel Storage Facility Compatibility Fund grant program provides funds to public and private fueling stations licensed under Oregon Revised Statute, Chapter 480.350. The program funds the installation of emergency generator connectors at fuel facilities that use card lock technology. The generator connectors will allow publically-owned generators to be connected in times of emergency, to provide fueling for life-saving and first responder needs.

The grant application period will close at 5 p.m. on Friday, January 20, 2017. All application materials must be submitted by this date to be considered as an applicant.
