Approval of Minutes:

Planning Commission Chair Wenholz read the Planning Commission Hearing Procedures.

Land Partition LP-N-471-19 and Replat R-N-052: Port of Morrow, applicant and owner. The property is described as tax lot 101 of Assessor's Map 4N 26 06. The property is zoned PI and located in the Port of Morrow East Beach Industrial Park approximately three miles east of the City of Boardman. Request is to Partition Plat 2011-19. Criteria for approval includes the Morrow County Subdivision Ordinance Article 5 Land Partitioning. Planning Technician Stephen Wrecsics presented the staff report and described the request.

Land Partition LP-N-472-19: James and Silvia Suter, applicants and owners. The property is described as tax lot 500 of Assessor's Map 4N 24E 24. The property is dual zoned EFU and FR and located two miles west of Boardman on Tom's Camp Road. Request is to create two parcels eliminating the dual zone configuration. Criteria for approval includes the Morrow County Zoning Ordinance Article 3 Section 3.010 Exclusive Farm Use and Article 5 Land Partitioning.

Planning Technician Stephen Wrecsics presented the staff report and described the request.

Opened the testimony portion of the Public Hearing.

In favor: James Suter. Applicant stated that the subject parcel is not currently serviced by West Extension Irrigation District (WEID). Amendments to the findings were proposed by staff to reflect subject parcel is not serviced by WEID.
