- 5. Operational Changes Information will be posted and shared with public upon Board of Commissioners Approval. The STIF was very supportive of upcoming service changes and
 - a. March 31, 2025 New Fixed Routes will begin. The routes include 3 new circulars, a boardman circular route and two North and South Morrow County connecting circular routes. The routes were designed to provide residents of Morrow County the opportunity to connect and have choice when seeking essential services
 - b. Service area Morrow County, Good Shepherd Hospital, Hermiston Wal-Mart, Veteran services in surrounding counties
 - c. Routes Discussed in section a
 - d. Public Notice Once changes have been approved by the Board of Commissioners' we will be holding open houses to share information on the service changes and help educate the public on how to use public transit
 - e. Radio/ Facebook/ Events New radio ads are in rotation to gain ridership
 - f. Animal/ Pet Policy A Service animal policy was established. MCPT does not currently have a policy
- 6. Signage Working with our city partners to establish posted bus stop signs to expand ridership and transit awareness
