The Loop – Morrow County Transportation is accepting quotes for the purchase of Portable Sanitization Equipment for our fleet. Please include warranties, hardware, shipping, training, and travel costs if applicable. Below is a list of our current fleet and locations where our fleet is stored. We would like each of our locations to have a sanitization unit, for a total of three units.

All units must be fully self-contained and man-portable weighing under fifty pounds. The applicator equipment shall include a hands-free and manual hand application option. The equipment must be capable of disinfecting multiple vehicles at the same time.

The disinfectant solution shall not be harmful to the environment, contain no VOCs, 100% biodegradable, and be ready to use solution – no mixing required. The solution must be safe to use on the interior of the vehicle leaving no residue behind. The solution must be proven effective against Novel Coronavirus (2019-nCoV), MRSA, HIV-1, Hepatitis B, Hepatitis C, Ebola, MERS, CRE, E. coli, Norovirus, H1N1, Legionella pneumophilia, Salmonella, Listeria, mold, and mildew. Please include one year of disinfectant solution in the quote.
